Notice to Requestor: A \$30.00 (30 Day)/\$50.00 (45 Days)/ \$100.00 (One Year) application fee is due at submission of the application. Before the City of La Grange issues a Peddler Permit, the police department shall perform an investigation of the elements of the application. Once the police department's investigation is completed, the requestor will be notified as to the approval or denial of the permit application. The police department will notify the requestor via telephone. The \$30.00/\$50.00/\$100.00 application fee shall not be refunded, regardless of whether or not such permit is issued or denied.

- Each applicant seeking a permit shall pay a fee of \$30.00 (30 day)/ \$50.00 (45 Days) or \$100.00 (One Year). The permit shall be issued for the length of time requested, not to exceed thirty (30) days or one (1) year from the date of application. Permits for handbill distribution shall be exempt from this time limitation.
